


Ms. Betty Kirksey is a real party in interest in this action. O.C.G.A. § 9-11-17. Ms. Kirksey purchased a 1999 Cadillac Deville on June 3, 2003 from Huckabee Buick-Cadillac-GMC in Macon, Georgia. On that date and in connection with her automobile loan, Ms. Kirksey purchased credit insurance from Defendant American General. She paid in full a single premium in the amount of \$466.88 for the credit insurance which covered the life of the loan. The scheduled expiration date of the credit insurance was June 18, 2008. Ms. Kirksey's loan was terminated on August 18, 2006, prior to the scheduled expiration date of her credit insurance. Under the terms of her credit insurance contract and under the laws of the State of Georgia, Ms. Kirksey was entitled to a refund of unearned premium. She has not received this refund from American General. Therefore, Ms. Kirksey is a member of the class for which the present action was brought, and she desires to be added as a named Plaintiff in this action.

Therefore, the parties request that the Court grant this consent motion and order that Betty H. Kirksey be added as a named Plaintiff to this action.







AS A NAMED PLAINTIFF IN THIS CLASS ACTION LITIGATION**


